2016 FALL CONFERENCE INFORMATION

PROFESSIONAL JUDICIAL DEVELOPMENT:

There will be no optional programming held at the fall conference.

CONFERENCE PRE-REGISTRATION:

To register for the conference, please complete the attached electronic registration form, and then submit it to the Mississippi Judicial College so that we may confirm your registration. You will then need to make your hotel reservations directly with the Pearl River Resort's Silver Star Hotel as instructed in this brochure.

ON-SITE REGISTRATION:

On-site fall conference registration will be Wednesday, October 5th from 1:00 to 1:30 p.m., in the lobby of the Silver Star Hotel Convention Center.

CONFERENCE:

The 2016 Fall Conference will provide the final 12 hours toward your statutorily required 24 hours of annual CJE training requirement. Certificates will be awarded following the last session on Friday, October 7th to those who complete 100% of the conference. If you will be unable to attend any or part of the conference, it is your responsibility to schedule a video make-up with MJC. DVDs will only be mailed in very limited circumstances.

LODGING:

TRAVEL AND MEAL REIMBURSEMENT:

A travel allowance of 54 cents per mile will be paid to judges who drive their own vehicle and live outside a 30-mile radius of Choctaw. Judges from the same county should consider car-pooling. A reimbursement form for meals and mileage will be provided in your MJC conference notebook at registration.

REIMBURSEMENT POLICY:

100% attendance of education class time is required of all MJC constituent groups who are eligible for reimbursement. This includes mileage, meals, and lodging.

MAKING YOUR RESERVATIONS



MJC has reserved a block of rooms for overnight accommodations for the 2016 Fall Conference at the Pearl River Resort's Silver Star Hotel. To make your reservations, you must contact the hotel and follow the instructions below to make and confirm your reservation. If for any reason it becomes necessary to cancel your reservation, then you will need to contact the hotel directly so that your credit card will not be charged as a "no show."

All reservations must be made directly by you and must be guaranteed by a major credit card. Please be sure to write down your confirmation number.

To make your reservation at the Silver Star Hotel, you will need to call **1-866-44-PEARL**, and identify yourself by the group code **GJCJF16**. Inform reservations of your selected arrival and departure dates and then guarantee with a major credit card. Reservations will give you a confirmation number. Please keep this number in case revisions need to be made to your reservation before the conference, and then when you arrive at the Silver Star.

*The deadline for making reservations in the MJC room block at the Silver Star Hotel is **Monday, September 19, 2016.***

Judges who live outside a 30-mile radius of Choctaw and attend 100% of the conference will have the room rate for *only* the nights of Wednesday, October 5th and Thursday, October 6th changed to MJC's master account *only after* you have checked into the hotel. MJC is not responsible for any incidentals charged to your room, as well as any requested room upgrades above our contracted room rate of \$83.00.

MJCJA Board members arriving on Tuesday, October 4th, and who will need overnight accommodations for that evening, will need to inform reservations of their earlier arrival date.

Please note that MJC can no longer take pre-payment from counties for hotel room rates. You will need to seek reimbursement for the night of October 4th from your county.

Any reservation requests made prior to and after these dates are subject to availability and the regular hotel rates.
